1. Volume – up to 2 full A4 pages.
2. Margins should be: top, bottom, right, left - 2cm, font - Times New Roman, 10 pt.; spacing - 1.0; paragraph - 1.0 cm.
3. The UDS is indicated in the upper left corner.
4. Title of presentation (capital "bold" letters) is indicated in the center.
5. The name and surname, rank, degree (for students - a group) are in the next row- normal font.
6. Next - the name of the institution (italic letters) after the free text string starts report.
7. At the end of the text - literature.

Materials must be received by organizing committee by 5 May, 2014:

1. The electronic version of the report. Subject and name of the file should be replied first author's surname materials.
2. The electronic version of the application.
3. A copy of the payment document (scan).

Materials that arrived after the deadline and those that do not correspond the requirements will not be considered. The Committee reserves the right to select submission.

Materials published in author's edition.
