REGULATIONS OF ADMISSION to Chernihiv Polytechnic National University for studying in 2022

Educational activity in Chernihiv Polytechnic National University (CPNU) is carried out according to the license of the Ministry of Education and Science (https://stu.cn.ua/normatyvna-baza/liczenziyi/).

Admission regulations have been developed by the CPNU Admissions Board (hereinafter – Admissions Board) complying with the Admission Requirements for Studying in 2022 (hereinafter – the Admission Requirements) approved by Order of the Ministry of Education and Science of Ukraine as of 13 October 2021 No.1098 registered with the Ministry of Justice of Ukraine on 26 November 2021 under No.1542/37164.

I. General Provisions

- 1. Admissions to CPNU is carried out on the competitive basis according to the corresponding sources of funding indicated in paragraph 1 of section III of there Regulations.
- 2. Admission of entrants to Chernihiv Polytechnic National University is carried out by the Admissions Board, the composition of which is approved by the order of the head of the higher education institution, who is its chairperson. The Admissions Board operates complying with the Regulation on the Admissions Board of the Higher Education Institution approved by the administration board of the higher education institution according to the Regulation on the Admissions Board of the Higher Education Institution approved by Order of the Ministry of Education and Science of Ukraine as of 15 October 2015 No.1085 registered with the Ministry of Justice of Ukraine under No.1353/27798.

CPNU Rector ensures compliance with the legislation of Ukraine, including the Admission Requirements, these Regulations and openness and transparency of the Admissions Board's work.

A decision made by the Admissions Board within its authority is grounds for the Rector to issue a corresponding order and/or implement the procedure of the admissions campaign.

All issues related to admissions to CPNU is resolved by the Admissions Board in their meetings. Decisions by the Admissions Board are posted on CPNU's official website on the day following the day when a decision was made.

II. Admission to Studying

- 1. The following persons are admitted to studying:
- persons who received complete general secondary education or Junior Specialist's degree, Junior Bachelor's degree to study for Bachelor's degree;
- persons who were awarded Bachelor's degree, Master's degree (corresponding to the educational and qualification level of Specialist) to study for Master's degree;

• persons who were awarded Master's degree (corresponding to the educational and qualification level of Specialist) to do PhD degree.

Persons who were awarded Bachelor's degree in specialties 081 "Law" or 293 "International Law" is subject areas 6.030401 "Law Science", 6.030202 "International Law" are admitted to do Master's degree in specialty 081 "Law".

To obtain a degree in another specialty, persons who have previously obtained the same or higher degree (level) of higher education or are doing it for at least one year and fully completing the individual curriculum are also accepted. The condition to enroll a student for simultaneous study in another specialty in the same or in another higher education institution is the fulfillment of requirements similar to the requirements for entrants to the relevant educational programs. These requirements can be met during the first year of study.

- 2. Entrants are enrolled in the first year of study. CPNU can transfer ECTS credits, the maximum amount of which is determined by the standard of higher education for bachelor degree (if not applicable no more than 120 ECTS credits), of persons who have received Junior Specialist's degree, professional Junior Bachelor's degree, or Junior Bachelor's degree. Such persons may be admitted to the second (senior) year(s) or to the first year of study (with a reduced period of study). To obtain a bachelor's degree in another specialty, individuals can be admitted to the first or senior years of study (including those with a reduced period of study).
- 3. Admission to study is conducted in specialties according to the List of Subject Areas and Specialties approved by Decree of the Cabinet of Ministers of Ukraine as of 29 April 2015 No.266 and interdisciplinary (educational-scientific) programs that comply with Requirements for Interdisciplinary Educational (Scientific) Programs approved by Order of the Ministry of Education and Science as of 01 February 2021 No.128 "On approval of Requirements for Interdisciplinary Educational (Scientific) Programs" registered with the Ministry of Justice of Ukraine on 06 April 2021 under No. 454/36076.

Admission of entrants to study is conducted based on competitive offers formed by CPNU and entered into the Unified State Electronic Database on Education in defined terms in the Requirements.

Names of competitive offers are formed without marks and abbreviations in the native language and duplicated in other languages.

- 4. Order No.271 defines rules of admitting students, whose place of residence is temporarily occupied territory of the Autonomous Republic of Crimea and the city of Sevastopol, temporarily occupied territory of individual districts of Donetsk and Luhansk regions, territory in the buffer zone, or those who moved out after 01 January 2022.
- 5. Admission rules to CPNU to take up Master educational-professional program under specialty 281 "Public Management and Administration" funded by the government upon the request of the National Public Service Agency of Ukraine are defined by the Procedure for admission to study under Master educational-professional program in specialty "Public Management and Administration", subject area "Public

Management and Administration" approved by Resolution of the Cabinet of Ministers of Ukraine as of 29 July 2009 No.789.

III. Sources of Funding for Students

- 1. Sources of funding for students are:
- funding from the state budget (public funding) and from local budgets (regional funding);
- student loans. Student loans are allocated according to the Procedure for allocating student loans for vocational and higher education approved by Resolution of the Cabinet of Minister of Ukraine as of 29 August 2018 No.673;
- vouchers:
- at the expense of individuals and/or legal entities (under the contract terms, in particular grants received by CPNU for research, which provides for the training of graduates of the degree of Doctor of Philosophy or Doctor of Science).
- 2. Citizens of Ukraine have the right for free higher education on the competitive basis according to higher education standards if it is the first time when a citizen is studying for the first degree at the expense of the state or local budget in public and municipal HEIs and according to open competitive offers in private HEIs that observe the legislation on indicative fee, formation and placement of state (regional) order and on condition that such institutions meet the requirements for placing state (regional) orders defined by these Requirements.

Persons who have received Specialist's degree at the expense of the state or local budget (under state or regional order) can do Master's degree only at the expense of individuals and/or legal entities, excluding cases set forth in paragraph 5 of this Section.

3. A person may enter Chernihiv Polytechnic National University to do a master's degree on the basis of a bachelor's degree, master's degree and educational qualification level obtained in another specialty (field of study) (taking into account the requirements of the fifth paragraph of paragraph 1 of section II of these Regulations), if they pass entrance examinations successfully. Funding at the expense of the state and local budgets (under state or regional order) is carried out within a period of study specified in the study plan.

Persons taking up bachelor studies on the basis of professional Junior Specialist's degree may be enrolled under state (regional) order on the first year of study with a shortened period of study if they choose the same or related to the subject area specialty, as well as the specialties listed in the List of specialties that receive special support (Annex 2).

Persons taking up bachelor studies on the basis of Junior Specialist's degree, professional Junior Specialist's degree, Junior Specialist's degree may be enrolled at the expense of individuals and/or legal entities on the first year of studying with a shortened period of study or on the second year of study, or senior years with a period of study within the licensed scope.

- 4. Citizens of Ukraine who failed to complete studies at the expense of the state or local budget (under state or regional order) to receive a particular degree have the right to re-enter the HEI for free higher education at the same level of education subject to reimbursement to the state or local budget of funds spent on training services according to the Procedure of reimbursement of the funds from the state or local budget spent on training services approved by the Cabinet of Ministers of Ukraine as of 26 August 2015 No.658.
- 5. Citizens of Ukraine have the right for free higher education in different specialty at CPNU:
- if their health condition does not allow them to perform professional roles and responsibilities according to the received qualification, which is supported by a medical and social expert commission, and in other cases provided by law;
- if they are directed to study by a state (regional) contracting authority according to the legislation.
- 6. Student loans are given to persons enrolled in the CPNU for full-time or parttime study mode on the basis of contracts concluded between CPNU and an individual or legal entity, namely:
- a long-term student loan is given for students according to Law of Ukraine "On rights and freedoms of internally displaced persons" who are registered complying with the law as internally displaced persons;
- a long-term student loan is given to students of HEIs regardless their form of ownership and cadets of non-military HEIs, the list of which is approved by the Cabinet of Ministers of Ukraine, before they turn 35 years old.
- 7. Foreigners and persons without citizenship, namely (1) foreign Ukrainians, who permanently live in Ukraine, (2) persons who are recognized as refugees, and (3) persons seeking additional protection, have the right for higher education on the same basis as Ukrainians either at the expense of the state budget or the local budget.
- 8. Persons studying at CPNU have the right to study under several educational programs and in several HEIs.

It is not allowed to study under two or more specialties (specializations, subject specialties, educational programs, levels, degrees, forms of education) at the expense of the state or local budget, excluding cases of combining subject areas, specialties, specializations (subject specializations) in one educational program. It is not allowed to do a master's degree in medicine, pharmacy or veterinary specialties on the basis of complete general secondary education or Junior Specialist's degree, professional Junior Bachelor's degree, Bachelor's degree, which is considered a simultaneous bachelor's and master's degree.

9. Entrants to do bachelor's degree on the basis of complete general secondary education are admitted to the competition for places under state (regional) order and may be recommended for enrollment or transfer for such places if their grade is no less than 125,000. Restrictions on the transfer to vacant places under a state (regional) order

do not apply to the persons specified in paragraph 11 of section VIII of these Regulations.

- 10. Admission to study in specialties 081 "Law" and 293 "International Law" under state or regional order to do junior bachelor's degree under all forms of education and to do bachelor's degree and master's degree in a part-time mode is not conducted in 2022.
- 11. HEIs training students under state (regional) order or at the expense of students loans define tuition fees according to the Procedure for establishing a minimum tuition fee for higher education based on the indicative fee approved by the Cabinet of Ministers of Ukraine as of 03 March 2020 No.191.

IV. Admission Scope and State (Regional) Order Scope

1. Admission is carried out within the licensed scope for a certain higher education level or for a certain educational program, which provides awarding professional qualifications in professions for which additional regulations have been introduced. The licensed scope determines the maximum total number students who can enter CPNU for studies during one calendar year (from January 1 to December 31), be renewed in it or transferred to it from other higher education institutions to receive higher education of the appropriate level, or the relevant educational program.

Admission to interdisciplinary educational (educational-scientific) programs is carried out within the licensed scope for a certain level of higher education. Admission to study under state order for interdisciplinary educational programs of primary level (short cycle) of higher education in a group of two specialties belonging to one or two fields of knowledge, is carried out in one of these specialties at the choice of Chernihiv Polytechnic National University. Admission to non-budget competitive proposals for other extended educational programs of primary level (short cycle) is carried out in one of their specialties (specialties of one of their fields of knowledge) at the choice of CPNU. Admission to interdisciplinary educational and scientific programs of the second (master's) level of higher education is carried out for those of them, for admission to which there is an entrance exam in the form of a single professional entrance examination for one of the specialties chosen by the higher education institution tests are provided for both specialties or not provided for either).

2. Admission to study under state order (at the expense of the state budget) is carried out on specialties and forms of higher education, according to which it is formed by the Cabinet of Ministers of Ukraine. The Ministry of Education and Science of Ukraine and other state customers determine from certain specialties lists of subject specialties and specializations for which the state order is formed and placed, according to the List of orders of state customers, which determine subject specialties and specializations of certain specialties state order.

Admission to study under regional order is carried out in specialties (specializations, interdisciplinary educational (educational-scientific) programs) and forms of higher education provided for by a regional customer for each higher education institution and form of higher education.

3. Scope of admission to study at the expense of individuals and/or legal entities on foxed and open competitive proposals is defined by CPNU within the difference between the licensed scope and the total (maximum) scope of the state or regional order, if necessary, a reserve for renewal or transfer to it from other higher education institutions for higher education of the appropriate level or according to the relevant educational program.

Admission to non-budget competitive proposal is defined by CPNU within the licensed scope for a certain higher education level or for a certain educational program that provides for awarding a professional qualification in professions, for which an additional regulation has been introduced.

4. The total scope of budget places for fixed competitive proposals, the maximum scope of budget places and qualification minimum of the state order for open competitive proposals quotas-1, quotas-2, quotas-3, quotas for foreigners for fixed and open competitive proposals, the amount of admission at the expense of individuals and / or legal entities to open and fixed competitive proposals, the amount of admission to non-budget competitive proposals are published on the official website of Chernihiv Polytechnic National University and are defined in the Regulations of Admission (after receiving the necessary information from the state (regional) customer).

V. Deadlines for applications and documents, competitive admiddions and enrollment

- 1. The order of the admission commission's work of CPNU in the period from July 14 to September 30, 2021:
 - Monday Friday: 09:00 to 17:00
 - Saturday: 9:00 to 13:00
- Sunday day off (in the absence of entrance examinations, consultations and acceptance of original documents).
- 2. Acceptance of applications and documents, entrance examinations, competitive admissions and enrollment of first-year entrants for the degree of junior bachelor, bachelor on the basis of complete general secondary education is carried out in the following terms:

The publication of the lists of persons recommended for enrollment based on the results of the interview with the notification of receiving or not receiving the right to higher education at the expense of the state or local budget (by state or regional order) is carried out no later than 12:00 on July 20. Applicants who have received recommendations must meet the requirements for enrollment in public procurement sites by 10:00 on July 22, including the submission of a written application to exclude applications for other public procurement sites. Enrollment of this category of entrants by state order takes place no later than 15:00 on July 22. Applications of enrolled persons to other places of the state order are excluded during July 22.

The publication of the lists of persons recommended for enrollment under quota-2, with notification of whether or not they have the right to obtain higher education at the expense of the state or local budget (by state or regional order) is carried out in several stages. The main stage - no later than 12:00 on July 20. Applicants who have received recommendations must meet the requirements for enrollment in public procurement sites by 10:00 on July 22, including the submission of a written application to exclude applications for other public procurement sites. Enrollment of this category of entrants by state order takes place no later than 15:00 on July 22. Applications of enrolled persons to other places of the state order are excluded during July 22. The final stage - no later than 12:00 on September 29. Applicants who have received recommendations must meet the requirements for enrollment in public procurement by 10:00 on September 30. The implementation of the final stage is carried out by transferring to vacant places of state, regional orders of persons enrolled in training at the expense of individuals and / or legal entities. Transfer of this category of entrants takes place no later than 15:00 on September 30.

Recommendations for enrollment and publication of the list of recommended entrants who apply for places at the expense of individuals and / or legal entities for open and fixed competitive proposals are provided no earlier than 18:00 on August 4.Terms of registration for participation in entrance exams and creative competitions for state and regional orders are determined by the Admissions Committee of Chernihiv Polytechnic National University, provided that applications and documents begin no later than June 24, last at least ten days and end before the last stream conducting entrance exams, creative competition. Information on the deadlines for applications and documents for participation in entrance exams, creative competition is published on the official website of the university.

Acceptance of applications and documents provided for in Section VI of these Regulations begins on June 13 and ends on June 16 for persons entering on the basis of entrance examinations (instead of a document on the level of education may be submitted a certificate of completion).

Relevant entrance exams to Chernihiv Polytechnic National University in the cases specified in these Regulations are held according to the schedule of the main, additional specially organized sessions of the unified entrance exam and the only professional entrance exam on materials (tasks / notebooks) provided by the Ukrainian Center for Educational Quality Assessment. The Ukrainian Center for Educational Quality Assessment provides materials for conducting entrance exams at a higher education institution no later than 11:30 a.m. on the day of the exam.

5. For admission to a master's degree on the basis of a bachelor's degree, the admissions committee may set additional deadlines for applications and documents, competitive admissions and enrollment at the expense of individuals and legal entities

from September 1 to November 30. The results of the unified professional entrance examination and / or the unified entrance examination (including a specially organized session of the unified entrance examination) obtained in the manner prescribed by the Terms of Admission, or the results of the professional entrance examination and / or entrance examination in a foreign language Chernihiv Polytechnic "in the cases provided by these Regulations.

- 6. Registration and work of electronic offices of entrants ends on September 30.
- 7. The Admissions Committee of Chernihiv Polytechnic National University may announce an additional set of entrants at the expense of individuals and / or legal entities on a full-time basis to obtain a bachelor's degree on the basis of complete general secondary education, junior specialist qualification level, junior bachelor's degree., a bachelor's degree, subject to enrollment of such entrants by September 30.

Acceptance of applications and documents for the second and third streams is announced by the Admissions Committee of Chernihiv Polytechnic National University in the presence of vacancies of the licensed volume, financed by individuals and legal entities.

8. The Admissions Committee of Chernihiv Polytechnic National University may enroll entrants at the expense of individuals and / or legal entities to obtain a master's degree on the basis of a master's degree (educational qualification level) in several stages (including before the deadline for admission) subject to enrollment. until November 30.

The results of the unified professional entrance examination and / or the unified entrance examination (including a specially organized session of the unified entrance examination) obtained in accordance with paragraphs 4-5 of this section or the results of the professional entrance examination and / or entrance examination in a foreign language shall be used. , drawn up in CPNU in the cases provided by these Regulations.

VI. The procedure for accepting applications and documents for participation in the competition in admissions to higher education

- 1. Applicants for higher education shall submit applications:
- ✓ only in electronic form, except for the cases specified in this paragraph;
 - ✓ only in paper form:
- to exercise the right to take the exams for admission to the HEI (in the absence of the entrant at least one of the certificates of EIT 2019-2022), an interview, according to the order № 271 in accordance with the Terms of Admission:
- to exercise the right to get re-education free of charge for the budget funds in accordance with the Terms of Admission;
- in case of discrepancies in the data of the applicant in USEDE (surname, name, date of birth, sex, citizenship, etc.) and in the relevant document on previously obtained education and in the EIT certificate;
 - in case of submission of a foreign document on education;

- in case of submission of documents by foreigners and stateless persons;
- in case of submission of a document on previously obtained education, issued before the introduction of photopolymer technologies for their production;
- in case of submitting an application after the expiration of the electronic cabinets;
- to exercise the right to accrual additional points provided for in paragraph 6 of section VII of these Regulations;
- in case of impossibility to register an electronic cabinet or submit an application in electronic form for other reasons, which is confirmed by the certificate of the admissions committee of CPNU.

Applicants, referred to in the fourth paragraph of this paragraph may submit applications in electronic form with subsequent submission of documents that confirm the right to the admission interview, which must be submitted to the deadlines for applications in accordance with these Regulations.

To exercise the right to take the exams for admission to the HEI in competitive subjects at CPNU and / or quota-1 (provided that there is at least one EIT certificate), the applicant before submitting the application in electronic form personally submits the original document (s), confirming the entrant's right to special conditions of participation in the competitive admiddions to the admissions committee of one of the selected institutions of higher education.

Applicants can submit up to **five applications** for state and regional procurement positions in closed and open competitive offers, and up to twenty applications for non-budget bids.

2. The application in electronic form is submitted by the entrant by filling in electronic form online and is considered by the university admissions committee in the manner prescribed by law.

Chernihiv Polytechnic National University has a consulting center at the Admissions Committee to assist entrants in submitting applications in electronic form. Applicants can apply to the counseling center of any higher education institution in order to create an electronic cabinet, submit applications in electronic form, download the supplement to the educational document on the basis of which admission takes place, certificate of residence (if necessary) in accordance with Annex 13 to the Regulations of registration of residence and the Procedure for transfer of information by registration authorities to the Unified State Demographic Register, approved by the resolution of the Cabinet of Ministers of Ukraine of March 2, 2016 № 207.

- 3. The applicant submits the application in paper form personally to the admission commission of Chernihiv Polytechnic National University. The information of each application in paper form is registered by the authorized person of the Admissions Committee in USEDE on the day of acceptance of the application.
- 4. In the application, applicants indicate the tender proposal indicating the specialty (specialization, educational program(s)) and the form of education.

While submitting applications for open and closed competitive offers, applicants must indicate one of the following options:

- "I apply to participate in the competition for a state or regional offers and to participate in the competition for places at the expense of individuals and / or legal entities in case of failure to receive a recommendation on this competitive offer at the expense of state or local budget (under state or regional order)";
- "I apply to participate in the competition exclusively for places at the expense of individuals and/or legal entities, notified of the impossibility to transfer within the admission campaign to places under state or regional order".

While submitting application for a non-budget competitive offer applicants apply for participation in competition exclusively at the expense of individuals and/or legal entities and are warned about the impossibility of transfer within the admission campaign to places of under state or regional order.

Applicants for a bachelor's degree program on the basis of complete general secondary education and applicants for a master's degree program on the basis of a bachelor's degree, master's degree (educational qualification level of specialist) in specialties in such fields of knowledge: 05 "Social and Behavioral Sciences", 07 "Management and Administration", 08 "Law", 28 "Public Management and Administration" applying for places under state or regional order for full-time or part-time education, should indicate the priority of each application; the priority indicator 1 (one) means the highest priority.

The priority of applications, specified by the applicant, cannot be changed.

To participate in admission competition in various forms of education applicants submit separate applications.

- 5. While submitting an application in paper form, the applicant personally presents the originals of the documents:
 - A document (one of the documents) certifying the identity provided by the Law of Ukraine "On the Unified State Demographic Register and documents confirming the citizenship of Ukraine, certifying the person or his/her special status";
 - Military registration document (for military liable a military ticket or a temporary conscript's certificate and for conscripts a certificate of registration in conscription stations);
 - A document (state standard) on a previously obtained educational degree (educational qualification level), on the basis of which the admission is made and its supplement;
 - ◆ A document confirming the applicant's right to be enrolled by the interview, to participate in the competition based on the result of entrance examinations and/or quota-1, quota-2 or quota − 3 on the basis of complete general secondary education, to participate in competition according to the examination results for admission to the HEI on a master's degree program on the basis of bachelor's degree, master's degree (educational qualification level of specialist) instead of foreign language EIT and/or single professional entrance exam.

Applicants residing in the temporary occupied territory of Ukraine moved from it after January 1, 2022, as well as applicants residing in territories where public authorities are temporary not exercising their powers, submit documents taking into account peculiarities provided by the Order No 271.

In case of objective reasons there is no certificate on the obtained educational degree, a certificate of a state enterprise "Інфоресурс" ("Inforesouce") or an extract from the Register of educational documents USEDE on an education acquisition may be submitted, in particular without submitting the supplement to the certificate.

- 6. To the application submitted in a paper form the applicant adds:
- Copy of a document (one of the documents) certifying the identity provided by the Law of Ukraine "On the Unified State Demographic Register and documents confirming the citizenship of Ukraine, certifying the identity or a special status"
- Military registration document (for military liable a military ticket or a temporary conscript's certificate and for conscripts a certificate of registration in conscription stations);
- A copy of a document (state standard) on a previously obtained educational degree (educational qualification level), on the basis of which the admission is made and its supplement;
- A document (state standard) on a previously obtained educational degree (educational qualification level) on the basis of which the admission is made and its supplement;
 - Four colour photographs 3*4 cm in size;
 - A copy of the registration number of the taxpayer's card.

In order to participate in the admission examination, creative competition for the place under state and regional orders based on the complete general secondary education, in addition to the application for participation in the creative competition (in the form specified by the Admission Committee of CPNU) the applicants also submit:

- A copy of an identity document;
- A photograph 3*4 cm in size;
- A certificate from the educational institution on the completion of complete general secondary education in case of absence of information about the obtained document on complete general secondary education in USEDE by July 10;
- A copy of a document confirming the applicant's right to participate in entrance examination.

Applicants are not required to submit other documents to participate in the entrance examination or creative competition.

Applicants allowed participating in the entrance examination, creative competition in case of presenting the original document certifying the identity, the original document confirming the right of the applicant to participate in the admission examination and examination sheet with a photograph.

Applicant submits other copies of documents in case of special conditions of admission to the relevant offers, established by law, within the time defined for the receiving documents.

- 7. Copies of documents certifying the grounds for obtaining special conditions for enrollment based on interview, for participation in the competition based on the results of admission examinations and/or quota-1, quota-2 based on the general secondary education, special condition for participation in the competition based on the results of admission examinations when applying for a master's degree based on a bachelor's degree, master's degree (educational qualification level of specialist), applicant submits personally all the documents in paper form within the terms specified in these Terms or in accordance to these terms. If documents are not submitted in time this makes their implementation impossible.
- 8. Copies of documents certifying the grounds for obtaining special conditions by a person, enrolled in HEI at the expense of individuals and/or legal entities, for transfer to vacant place under the state order and at the expense of targeted preferential state loans, the applicant submits personally at the same time with implementation of requirements for enrollment at the expense of individuals and/or legal entities:
 - For obtaining a bachelor's degree based on complete general secondary education no later than August 11;
 - For obtaining a master's degree on such programs: 05 "Social and Behavioral Sciences", 07 "Management and Administration", 08 "Law", 28 "Public Management and Administration" no later than August 15.

If documents, certifying the grounds for obtaining special conditions for transfer to a vacant place under state order and at the expense of targeted preferential sate loan, are not submitted in time this makes their implementation impossible.

- 9. The Admission Committee of CPNU certified the copies of documents, only if originals are presented, except a document certifying a person and military registration document. Copies of documents without presentation of originals are not accepted.
- 10. The Admissions Committee checks the grounds for obtaining special conditions for enrollment based on the interview, for participation in the competition based on the results of admission examinations and / or quota-1, quota-2 based on the complete general secondary education, special conditions for participation in the competition based on the results of admission examinations to obtain a master's degree based on a bachelor's degree, master's degree (educational qualification level) and special conditions for persons enrolled in HEI at the expense of individuals and / or legal entities to obtain a bachelor's degree on the basis of complete secondary education, a master's degree based on a bachelor's degree, a master's degree (educational qualification level of a specialist) for transferring to vacant places under state orders and targeted preferential state loans.

The Admission Committee checks the average score of the educational document submitted in paper form, approves it by its decision and fills the information about the average score of the educational document in USEDE database. If the applicant submits

an application in electronic form, the admissions committee checks the average score of the education certificate on the basis of its scanned copy (photocopy).

- 11. The Admissions Committee considers applications and documents admission of applicants and decides on admission to the competitive admissions to study at CPNU within three working days from the date of registration of the application in USEDE, but not later than the next day after the end of the acceptance of documents, in case of passing the admission examinations not later than the next day after the end of the admission examinations.
- 12. The fact of acquaintance of the applicant with the Regulations of reception available license and certificate of accreditation of the relevant educational program (specialty), as well as the fact of presence / absence of grounds for participation in competition based on the results of admission examinations, enrollment by interview, enrollment by quota-1, quota-2, quota-3 are recorded in the application of the applicant and confirmed by his personal signature when submitting the application.

In the case of submission of documents for non-accredited educational programs (specialties) the fact of acquaintance of the entrant with part six of Article 7 of the Law of Ukraine "On Higher Education" is recorded in a written notice of awareness of lack of accreditation and confirmed with the personal signature when submitting the application in paper form.

The applicant has the right to cancel the previously submitted, registered and admitted to the competition in HEI application in his/her electronic office before the deadline for submission of electronic applications, without the right of submission a new application with the same priority.

- 13. When admitting persons who apply for a degree of education (hereinafter the Document), the procedure for recognition and establishment of equivalence is mandatory Document carried out in accordance with the order of the Ministry of Education and Science of Ukraine dated May 5, 2015 No 504 "Some issues of recognition in Ukraine of foreign educational documents", registered with the Ministry of Justice of Ukraine on May 27, 2015 under No 614/27059.
- 14. When admitting persons who apply for a document on higher spiritual education, issued by an institution of higher spiritual education before September 1, 2018, it is mandatory to submit a Certificate of State Recognition a document on higher spiritual education or a decision of the Academic Council of a higher education institution on the recognition of the specified document in the manner prescribed by law.
- 15. When submitting applications and documents for a bachelor's degree based on the educational qualification level of a junior specialist may be accepted as documents on the educational qualification level of a junior specialist prepared in accordance with the Cabinet of Ministers of Ukraine dated September 9, 2020 No 811 "On documents on higher education (scientific degrees) "and documents on the educational and qualification level of junior specialists, prepared in accordance with the resolution of the Cabinet of Ministers of Ukraine of July 22, 2015 No 645" On

documents on professional education of the state standard and supplements to them".

VII. Competitive admissions, its organization and procedure

- 1. Competitive admissions to studies is carried out on the basis of entrance examination results:
- to enter the first year of study for a bachelor's degree on the basis of complete general secondary education in the form of external independent examinations, creative competitions, entrance examinations or interviews in the cases provided by the Regulations of Admission. In 2022, external independent examination certifications of 2019, 2020, 2021 and 2022 shall be accepted. If a foreign language is established as a competitive subject, the entrant has the right to submit a grade from certificates in one of the foreign languages (English, German, French or Spanish) at their own discretion;
- to enter the study for a master's degree on the basis of a higher education degree in the field of knowledge 05 "Social and Behavioral Sciences", 07 "Management and Administration", 08 "Law", 28 "Public Management and Administration" in the form of a single entrance examination in a foreign language and a single professional entrance examination (subject to successful completion of a single entrance examination in a foreign language, passed in 2020, 2021 or 2022 and each block of a single professional entrance examination passed in the year of entry) or entrance examinations in the cases provided by the Regulations of Admission;
- to enter the study for a master's degree on the basis of the degree (educational qualification level) of higher education in other specialties in the form of a single entrance examination in a foreign language (except as provided by the Regulations of Admission), passed in 2020, 2021 or 2022, and professional entrance examinations passed in the year of entry;
- to enter the study for a bachelor's degree on the basis of the educational qualification level of a junior specialist, the educational and professional degree of a junior bachelor, a bachelor's degree in the form of external independent examination and professional entrance examination in cases specified by the Admission Conditions. In 2022, external independent examination certificates of 2019-2022 shall be accepted.
- 2. Competitive admissions is conducted on the basis of a competitive grade, which is calculated according to these Regulations and Admission Conditions.
- 3. For the competitive selection of persons who, on the basis of a complete general secondary education, enter the first year to obtain a bachelor's degree, the points of the certificate(s) of external independent evaluation (ZNO) (results of entrance exams, creative competitions) from three competitive subjects are counted. The list of competitive subjects and creative competitions for admission to study for a bachelor's degree **on open, fixed and non-budgetary competitive offers** based on complete general secondary education is defined in Appendix 3 to these Rules. Within the competitive admissions of persons.

If a foreign language is set as a competitive subject, the entrant has the right to submit an assessment from certificates from one of the foreign languages (English, German, French or Spanish) at his own discretion

- 4. For the competitive selection of persons who, on the basis of a bachelor's degree, a master's degree (educational and qualification level of a specialist), enroll in studies to obtain a master's degree, are enrolled:
 - ➤ for admission to the specialty branches of knowledge 05 "Social and Behavioral Sciences", 07 "Management and Administration", 08 "Law", 28 "Public Management and Administration":
- the results of a single entrance exam in a foreign language in the form of a foreign language test (English, German, French or Spanish) or an entrance exam in the cases provided for in clauses 14, 15 of Chapter VIII of these Rules;
- the results of a single professional entrance test, the components of which are a subject test and a test of general educational competence (hereinafter referred to as TZNK) or an entrance exam in the cases provided for in clauses 14, 15 of Chapter VIII of these Rules;
 - > for admission to other specialties:
- the results of a single entrance exam in a foreign language in the form of a foreign language test (English, German, French or Spanish) or an entrance test in a foreign language (in cases stipulated by these Rules);
- the results of the professional entrance test.

To persons who, in the year of admission, took the single state qualification exam at the first (bachelor) level of higher education in the relevant specialty in accordance with the Resolution of the Cabinet of Ministers of Ukraine of May 19, 2021 No. 497 "On the attestation of holders of professional preliminary higher education degrees and degrees of higher education at the first (bachelor's) and second (master's) levels in the form of a unified state qualification exam", the result of this exam is counted as the result of the professional entrance test.

For graduates of Chernihiv Polytechnic National University in 2022, by decision of the admissions committee, the results of the final attestation for the bachelor's degree can be counted as the result of the professional entrance test.

- 5. The specifics of the competitive selection of persons entering studies for the degree of Doctor of Philosophy are determined by the Rules of Admission to Postgraduate Studies of Chernihiv Polytechnic National University, which are an appendix to these Rules.
 - 6. The competitive score is calculated:
 - > for entry into the first year for a bachelor's degree on the basis of a complete general secondary education according to the formula:

Competitive score (CS) = $C1 \times P1 + C2 \times P2 + C3 \times P3 + C4 \times A + C6 \times OU$,

where P1, P2 - grades of external independent assessment (ZNO) or entrance exams in the first and second subjects; P3 - assessment of external independent assessment, entrance exam in the third subject or creative competition (on a scale of 100-200); A - the average score of the document on complete general secondary education, converted to a scale from 100 to 200 points in accordance with the table of conversion of the average score of the document on complete general secondary education, calculated on a 12-point scale, to a scale of 100–200; OU - a point for successfully completing the preparatory courses of a higher education institution in the year of admission for admission to it on a scale of 100 to 200 points in the case of admission to the majors (specializations) specified in the List of majors that receive special support.

Grades from the document on complete general secondary education, which are presented on a 5-point scale, are taken into account as follows: "3" corresponds to "6", "4" corresponds to "9", "5" corresponds to "12". In the absence, for objective reasons, of an appendix to the document on complete general secondary education, its average score on a 12-point scale is considered equal to 2.

Individuals who are members of national teams of Ukraine and participated in international Olympiads (according to the orders of the Ministry of Education and Science of Ukraine), Olympic, Paralympic and De-Olympic Games (according to the proposal of the Ministry of Youth and Sports of Ukraine) are credited with scores of 200 points from two entrance tests at the entrant's choice.

Prize-winners and winners of the European and World Championships in Olympic sports (in particular among schoolchildren), the World Gymnasium, the championships of Ukraine (in Olympic sports) during admission to study in the specialty 017 "Physical Culture and Sports", the last addition is set equal to 10, and if the entrant's competitive score exceeds 200, it is set equal to 200. The document confirming the status of the prize-winner or winner of the mentioned competitions is a diploma (certificate, certificate, etc.) issued by the organizers of the competition specifying the name and surname of the person, the name of the competition, date, venue, place occupied and the result.

Prize-winners (persons awarded diplomas of the I-III degrees) of the IV stage of the All-Ukrainian Student Olympiads in the year of admission from basic subjects during admission to majors specified in the list of majors that receive special support (Appendix 2), the last addition is set equal to 10, and if at the same time, the competitive score of the entrant exceeds 200, it is set equal to 200. Admission commissions receive information about them from the Unified State Database on Education (USDE).

Finally, the competitive score is multiplied by the regional (RC), industry (IC) and village (VK) coefficients by multiplying it by their product, and for Chernihiv Polytechnic National University:

- RC is equal to 1,04;
- IC is equal to 1.02 for submitted applications with priority 1 and 2 in the specialties provided for in the List of specialties that are provided with special support; 1.00 in other cases;
- VC is equal to 1.02 for persons registered in villages and who obtained full general secondary education in educational institutions located on the territory of villages in the year of admission (1.05 for specialties provided for in the List of specialties that receive special support); 1.00 in other cases.

Entrants provide a certificate of residence registration (if necessary) in accordance with Appendix 13 to the Rules for Registration of Residence and the Procedure for Transfer of Information by Registration Authorities to the Unified State

Demographic Register, approved by Resolution No. 207 of the Cabinet of Ministers of Ukraine dated March 2, 2016.

VC for persons who are internally displaced and live in a village without registration is not applicable.

The Admissions Committee verifies the application of the VK in accordance with Appendix 13 to the Rules for Registration of Place of Residence and the Procedure for Transferring Information by Registration Authorities to the Unified State Demographic Register, approved by Resolution No. 207 of the Cabinet of Ministers of Ukraine dated March 2, 2016, submitted in paper form, approves it by its decision and enters information into the EDEBO. If the applicant submits an application in electronic form, the admissions committee verifies the application of the VK in accordance with the certificate on the basis of its scanned copy (photocopy).

If, after multiplying by coefficients, the competitive score exceeds 200, it is set equal to 200.

For admission to study for a master's degree in the fields of knowledge 05 "Social and Behavioral Sciences", 07 "Management and Administration", 08 "Law", 28 "Public Management and Administration" according to the following formula:

➤ for admission to study for a bachelor's degree on the basis of a bachelor's, specialist's or master's diploma obtained with another specialty, applicants have the opportunity to enter senior courses based on the results of a professional entrance test.

Enrollment is carried out for vacant places of the license volume, which is announced by the Admissions Committee before the start of accepting documents.

The course for which enrollment will take place is determined by the Admissions Committee on the proposal of the dean of the relevant faculty. The maximum permissible amount of academic difference for such enrollment in senior courses cannot exceed 20 credits.

Competitive selection is based on the results of the entrance exam. The entrance exam is conducted according to the professional entrance test program for persons entering the relevant field on the basis of the educational and qualification level junior specialist. In the event that several entrants with the same exam result apply for the same place, the admissions committee takes into account the average score in the appendix to the issued diploma.

If entrants of this category and those who enter on the basis of a diploma of junior specialist apply for the vacant places of the license volume on a certain course, then enrollment is carried out on the basis of a general competition for these two categories of entrants.

7. In the absence of an appendix to the document on the obtained educational degree (educational qualification level) for objective reasons, its average score is considered to correspond to the minimum possible value.

The principle of equality of rights of entrants must be observed for the different number of components in the competitive ball.

8. Chernihiv Polytechnic National University independently determines the minimum number of points from the entrance tests with which an applicant is allowed to participate in the competition (Appendix 3).

The competitive score for admission on the basis of a complete general secondary education cannot be less than 140 points for specialties 081 "Law" and 281 "Public Management and Administration".

9. The results of entrance exams and creative competitions are evaluated on a scale from 100 to 200 points.

The grade for the creative competition is calculated as the arithmetic average of the points received for each task of the competition, which cannot be more than three.

Entrants who received an assessment below the minimum score set by the admissions committee are not allowed to participate in the competitive selection for study.

10. The interview programs, which include the procedure for evaluating the interview results, are approved by the head of the admissions committee of Chernihiv Polytechnic University no later than March 31 of the corresponding year of the admission campaign.

Entrance exams for entrants on the basis of complete general secondary education and for entrants on the basis of the educational and qualification level of junior specialist, educational and professional degree of professional junior bachelor, educational degree of junior bachelor, which they pass instead of external independent evaluation, are conducted according to programs of external independent evaluation. Foreign language entrance exams for master's degree applicants are held according to the single entrance exam program. The head of the admissions committee approves the

evaluation procedure based on the results of the entrance exam, which should include the structure of the final score.

Creative contest programs, evaluation structure and evaluation procedure, programs of other entrance tests are developed and approved by the head of the admissions commission of Chernihiv Polytechnic National University no later than March 31 of the corresponding year of the entrance campaign. It is not allowed to include in creative contests tasks that go beyond the limits of the specified programs.

The programs of interviews, entrance exams, professional tests and creative competitions must be published on the university's website. The programs must contain evaluation criteria, the evaluation structure, and the procedure for evaluating the readiness of entrants.

- 11. Persons who, without valid reasons (recognized as such by the decision of the Admissions Committee), did not appear for the entrance tests at the time specified in the schedule, persons whose knowledge was assessed with points below the minimum value established by the Admission Rules, as well as persons who collected documents after the end date acceptance of documents, participation in subsequent entrance tests and competitive selection are not allowed. Retaking entrance exams is not allowed.
- 12. Appeals on the results of entrance tests conducted by Chernihiv Polytechnic National University are considered by the appeal commission, the composition and procedure of which is approved by the rector's order.
- 13. Information about the results of the entrance tests and other competitive indicators is entered into the record of the entrant in USDE.
- 14. By decision of the admissions committee, the results of the entrance exam in a competitive subject for admission to a certain competitive offer may be counted upon the application of the entrant to participate in the competitive selection for another competitive offer at Chernihiv Polytechnic National University.
- 15. The official announcement of the results of creative competitions for places of state and regional order, including evaluations of individual sessions of creative competitions and information on the achievement of the minimum passing score, is carried out by posting relevant information on the official website of Chernihiv Polytechnic National University and is submitted to the USDE no later than the next day after they are held .

VIII. Special Conditions for Participation in Competitive Admission to Higher Education

- 1. Special conditions for participation in competitive admission while entering for higher education acquisition based on the complete secondary education are:
 - Enrollment by an interview;
 - Participation in competitive admission based on examinations and/or quota-1, quota-2.

Participation in competitive admission based on the examinations is a special condition for competitive admission based on the educational-professional level of Junior Specialist, educational-professional level of Professional Junior Bachelor, educational level of Junior Bachelor.

Participation in the competitive admission based on the examinations in CPNU instead of unified professional entrance examination and/or unified entrance examination is special condition for participation in competitive admission while entering for higher education acquisition based on the received Bachelor's degree, Master's degree (educational-professional level of Specialist).

Special conditions for higher education acquisition at the expense of state or local budget (under state and regional order) and at the expense of targeted preferential government loans and based on the complete secondary education are:

- Enrollment based on the results of interview, quota-1, quota-2 on places under state and regional order;
- Enrollment based on quota-3 on places under regional order;
- Transfer to vacant places under state and regional orders of individuals in manner prescribed by these Regulations, if they are enrolled on studying on other sources of funding for open and fixed competitive offer;
- Transfer to places at the expense of targeted preferential government loans of individuals in manner, prescribed by the Law if they are enrolled on studying at the expense of individuals and/or legal entities.

Information concerned individuals, who have rights and special conditions of participation in competitive admission while entering HEI, is entered into USEDE system (with the addition of scan copies of documents, certifying these rights).

- 2. Entrance examinations are held in the form of an interview and in case of a positive conclusion about passing the interview an individual is recommended to enroll during the entering for higher education based on the complete general secondary education:
- individuals with disabilities as a result of war in accordance with Article 7 of the Law of Ukraine "On the Status of War Veterans, Guarantees of Their Social Protection" (in particular based on the educational-professional level of Junior

Specialist, educational-professional level of Professional Junior Bachelor, educational level of Junior Bachelor);

- individuals who, by the Law of Ukraine "On the Status and Social Protection of Citizens Affected by the Chornobyl Accident", have been granted the right to be admitted to state higher education institutions without examinations based on the results of an interview;
- individuals with disabilities who are unable to attend an educational institution (on the recommendation of the health and social protection authorities).

If such individuals are recommended for admission to an open or fixed offer, they are enrolled in places under state or regional order (unless the application states: ""I apply to participate in the competition exclusively for places at the expense of individuals and / or legal entities, notified of the impossibility of transfer within the admission campaign to places of state or regional order").

- 3. Entrance examinations are held in the form of entrance examinations (instead of external independent assessment) and in case of receiving the number of points for each of the exams not less than the minimum level set by the higher education institution are allowed to participate in competitive admission while entering HEI based on the complete secondary education or educational-professional level of Junior Specialist, educational-professional level of Professional Junior Bachelor, educational level of Junior Bachelor:
- individuals recognized as victims of the Revolution of Dignity, participants in hostilities in accordance with the Law of Ukraine "On the Status of War Veterans, Guarantees of Their Social Protection", including those who serve in the military (except conscripts) in the manner prescribed by the relevant conditions of military service by citizens of Ukraine.

Individuals of these categories participate in the competitive selection based on the results of entrance examinations in 2022 or external independent evaluation in 2019-2022 (in any combination of their choice). If such persons are admitted to the competitive admission for open or fixed competitive offer complete general secondary education, they participate in the competitive selection within the quota-1 for places of state or regional order (unless the application states: "I apply for participation in the competition exclusively for places at the expense of individuals and / or legal entities, notified of the impossibility of transfer within the admission campaign to the places of state or regional order").

4. Entrance examinations are held in the form of entrance examinations (instead of external independent assessment) and in case of receiving the number of points for each of the examinations not less than the minimum level set by the higher education institution are allowed to participate in competitive selection when entering to HEI based on the complete secondary education or educational-

professional level of Junior Specialist, educational-professional level of Professional Junior Bachelor, educational level of Junior Bachelor:

• individuals who, according to the decision of the Regulatory Commission at the Regional Center for Educational Quality Assessment, were denied in registration for participation in the external independent evaluation in 2022 due to the impossibility of creating special conditions (in case of submitting a copy of the medical certificate accounting documentation No 086-3 / o "Medical conclusion on the creation of special conditions for external independent evaluation", approved by the order of the Ministry of Education and Science of Ukraine, Ministry of Health of Ukraine dated August 29, 2016 No 1027/900 "Some issues of participation in external independent assessment and admission examinations of individuals with certain diseases and / or pathological conditions, disability", registered with the Ministry of Justice of Ukraine on December 27, 2016 under No 1707/29837, certified by the Secretary of the Regulatory Commission at the Regional Education Quality Assessment Center and the relevant extract from the minutes of the meeting of the regulatory commission at the Regional Education Quality Assessment Center).

Such individuals participate in the competitive admission based on the results of entrance examinations in 2022 and/or external independent assessment in 2019-2021 (in any combination of their choice). In case such individuals are admitted to the competitive admission for open or fixed competitive offer based on the complete secondary education, they participate in competitive selection within quota-1 for places of state or regional order (unless the application states: : "I apply for participation in the competition exclusively for places at the expense of individuals and / or legal entities, notified of the impossibility of transfer within the admission campaign to the places of state or regional order").

For visually impaired applicants who use Braille in the studying process and require special condition under code 0205 of the List of special conditions created for the individuals with special studying needs in external independent assessment venue, approved by the order of the Ministry of Education and Science of Ukraine, the Ministry of Health of Ukraine of August 29, 2016 No 1027/900, registered with the Ministry of Justice of Ukraine on December 27, 2016 for No 1708/29838, entrance examinations in geography, physics, chemistry, English, Spanish, German and French languages are held at the CPNU.

5. Entrance examinations are held in the form of entrance examinations instead of external independent assessment (if you do not make an external independent assessment in the relevant subjects in 2022) and in the case obtaining the number of points for each of the exams not less than set by higher education institution are allowed to participate in the competitive selection during the admission for higher education based on the complete secondary education or educational-professional level of Junior Specialist, educational-professional level of Professional Junior Bachelor, educational level of Junior Bachelor:

• Individuals, who in 2022 did not participate in the main and additional sessions of external independent evaluation of a particular subject(s) due to the presence of a disease or pathological condition specified in the List of diseases and pathological conditions that may be an obstacle to passing an external independent evaluation, approved by the order of the Ministry of Education and Science of Ukraine, the Ministry of Health of Ukraine of August 29, 2016 No1027/900, registered with the Ministry of Justice of Ukraine on December 27, 2016 under No 1707/29837 (subject to submission to the admissions committee of a higher education institution of one of the documents specified in subparagraph 1 of paragraph 2 of the order of the Ministry of Education and Science of Ukraine, Ministry of Health Of Ukraine of August 29, 2016 No 1027/900 "Some issues of participation in the external independent assessment and entrance examinations of individuals with certain diseases and / or pathological conditions, disabilities", registered in the Ministry of Justice of Ukraine on December 27, 2016 for No 1707/29837, or a copy of such document).

Such individuals participate in competitive admission based on entrance examination of (a) particular subject/s in case the main or additional session of an external independent assessment in 2022, and/or external independent assessment in 2019-2022 was not taken on this/these subject(s) (in any combination of their choice). If such individuals are admitted to the competitive selection for open or fixed offer based on the complete general secondary education, they participate in the competitive selection within the quota-1 for places of state or regional order (unless the application states: "I apply for participation in the competition exclusively to places at the expense of individuals and / or legal entities, notified of the impossibility of transfer within the admission campaign to the places of state or regional order").

If the individuals specified in paragraphs 2-5 of this section have expressed a desire to participate in the competitive selection only based on the results of an external independent assessment, they participate in the competitive admission within quota-1 for such results.

- 6. Entrance examinations are held in the form of entrance examinations (instead of external independent assessment) to higher education institutions determined in accordance with Order No 271, and in case of obtaining the number of points for each of examinations not less than the minimum established by the higher education institution, such applicants are allowed to participate in the competitive admission:
 - Individuals, whose place of residence is the temporarily occupied territory of some districts of Donetsk and Luhansk regions, the territory of settlements on lines of collision, the temporarily occupied territory of the Autonomous Republic of Crimea and the cities of Sevastopol (which are not registered as internally displaced persons) or moved from it after January 1, 2022.

Such individuals participate in the competitive selection based on the results entrance examination (taking into account the peculiarities of conducting of state final attestation Educational Centers "Crimea-Ukraine", "Donbass-Ukraine" or

without such consideration for individuals who have received a document of complete secondary education) and / or external independent evaluation (in any combinations of their choice). If citizens of Ukraine from among such individuals are admitted to competitive admission for open or fixed competitive offer, they participate in the competitive selection within quota-2 for places of state or regional order (unless the application states: "I apply for participation in the competition exclusively to places at the expense of individuals and / or legal entities, notified of the impossibility of transfer within the admission campaign to the places of state or regional order").

7. Entrance examinations are held in the form of entrance examinations (instead of external independent assessment and if an applicant do not pass the external independent assessment in the relevant subjects in 2022) and in the case of obtaining the number of points for each of the examinations not less than set by higher education institution the minimum level are allowed to participate in the competitive admission:

- Individuals, discharged from military service starting from December 1, 2021 including;
- Citizens of Ukraine, who obtained the complete general secondary education abroad within the period of September 1, 2021 and November 30, 2022.

Individuals among these categories can participate in competitive admission based on results of the entrance examinations and/or external independent assessment (the results of entrance examinations are credited if an applicant does not take an external independent assessment on particular subject).

- 8. Participate in competitive selection within quota-1 for places of state and regional order (unless the application states: "I apply for participation in the competition exclusively to places at the expense of individuals and / or legal entities, notified of the impossibility of transfer within the admission campaign to the places of state or regional order"):
- orphans, children deprived of parental care, individuals from among them.
- 9. Participate in competitive admission within quota-3 on the places of regional order (unless the application states: "I apply for participation in the competition exclusively to places at the expense of individuals and / or legal entities, notified of the impossibility of transfer within the admission campaign to the places of state or regional order"):
- Individuals, who obtained complete general secondary education in educational institutions of a certain administrative-territorial unit when applying for competitive offers, for which quota-3 is submitted.
- 10.Individuals, who require special conditions for participation in the competitive selection for higher education acquisition of the state (regional) offer and at the expense of targeted preferential state loans based on complete general secondary education in accordance with paragraphs two to six, eighth to ninth of this section

- and were not included in the state (regional) offer, have the right to participate in the competition on a general basis in accordance with the competition grade.
- 11. Transferred to vacant places of the state or regional order in the order provided by these Conditions if they are enrolled in studying on other sources of financing on open or fixed competitive offer and did not receive a recommendation for state or regional procurement could be the following individuals:
- Individuals, whose parents died (has gone missing) in the area of the anti-terrorist operation, measures to ensure national security and defense, repel and deter armed aggression of the Russian Federation in Donetsk and Luhansk regions, hostilities or armed conflicts or died of injuries, contusions or injury, obtained in the area of the anti-terrorist operation, implementation measures to ensure national security and defense, repel and deter armed aggression by the Russian Federation in Donetsk and Luhansk regions, hostilities or armed conflicts, as well as a result of a disease acquired during the period of participation in the anti-terrorist operation, implementation of measures to ensure national security and defense, repulse and deter armed aggression of the Russian Federation in Donetsk and Luhansk regions;
- Individuals, whose parents died or were injured as a result of injury, mutilation, contusion or other damage to health received during participation in the Revolution of Dignity;
- Individuals, whose parents are participants in hostilities on the territory of other states, who died (has gone missing) or died as a result of injury, contusion or mutilation received during hostilities and conflicts in the territory of other states, as well as a result of disease related to with being on the territory of other states during these actions and conflicts;
- Individuals, whose one of the parents (adoptive parents) was a serviceman who died or was declared missing by a court during his military service;
- Individuals, whose one of the parents (adoptive parents) was a policeman who died or was declared missing person in the course of his/her official duties, within three years after obtaining complete secondary education;
- 12. Transferred to vacant places of the state or regional order in the order provided by these Conditions if they are enrolled in studying on other sources of financing on open or fixed competitive offer and did not receive a recommendation for state or regional procurement could be the following individuals:
- Individuals with disabilities of groups I, II and children with disabilities under 18 years of age, who are not contraindicated to study in the chosen specialty;
- Individuals with disabilities from among the participants in the liquidation of the Chernobyl accident and victims of the Chernobyl disaster, for whom a causal link of disability with the Chernobyl disaster has been established, Chornobyl radiation sickness (category 1) and individuals, who permanently lived in the unconditional zone (compulsory) resettlement from the moment of the accident until the decision on resettlement (category 2);

- Children of individuals (as well as individuals from among them who completed general secondary education in the year of admission), recognized as victims of the Revolution of Dignity, participants in hostilities, persons with disabilities due to war, according to the Law of Ukraine "On the Status of War Veterans protection, guarantees of their social protection";
- Miners with at least three years of underground work experience and three years after completing general secondary education, whose parents are miners with at least 15 years of underground work experience or who have died as a result of an accident at work or became individuals with disabilities of the I or II group;
- Individuals, who require special conditions for participation in the competitive selection for higher education acquisition of the state (regional) order and at the expense of targeted preferential state loans based on complete general secondary education in accordance with paragraphs 2-6 and 8 of this section and have not been included in the places of state (regional) order (unless the relevant applications state: "I apply to participate in the competition exclusively for places at the expense of individuals and / or legal entities, notified of the impossibility of transfer within the admission campaign to places of state or regional order").
- 13. Transferred to vacant places of the state or regional order in the order provided by these Conditions if individuals are enrolled in studying on other sources of financing on open or a fixed offer, as well as places at the expense of targeted preferential state loans of individuals in the manner prescribed by law, if they are enrolled in training at the expense of individuals and / or legal entities and have not received a recommendation for places of state or regional order could be the following individuals:
 - Individuals, who are internally displaced persons in accordance with the Law of Ukraine "On Ensuring the Rights and Freedoms of Internally Displaced Persons";
 - children from large families (five or more children).
- 14. Enter for a Master's degree in the following specialties: 05 "Social and Behavioral Sciences", 07 "Management and Administration", 08 "Law", 28 "Public Management and Administration" participate in the competitive selection based on the results of entrance exams to CPNU (instead of a single entrance examination in a foreign language and a single professional entrance test) and when entering for a master's degree in all other specialties (instead of a single entrance exam in a foreign language) could the following individuals:
 - Individuals, who are unable to take the single entrance examination and / or the single professional entrance examination due to the presence of diseases listed in the List of Diseases and Pathological Conditions that may be an obstacle to external independent evaluation approved by the Ministry of Education and Science of Ukraine; Ministry of Health of Ukraine of August 29, 2016 No

- 1027/900, registered with the Ministry of Justice of Ukraine on December 27, 2016 under No 1707/29837;
- Individuals, who in order to complete the single entrance examination and / or the single professional entrance examination, require other special conditions except those specified in the List of special conditions created for individuals with special educational needs in the points of external independent assessment, approved by the order of the Ministry of Education and Science of Ukraine, the Ministry of Protection of Health of Ukraine dated August 29, 2016 No 1027/900, registered with the Ministry of Justice of Ukraine on December 27, 2016 under No 1708/29838, under codes 0101-0105, 0201-0203, 0206, 0301-0306, 0401, 0501, 0601, 0701, 0702;
- Individuals, who are discharged from all types of military service from April 1, 2022.
- 15. When applying for higher education acquisition at the expense of individuals and / or legal entities for competitive proposals, which in accordance with these Regulations provide for a single entrance examination and / or a single professional entrance examination (except for specialty 081 "Law"), applicants based on a Master's degree (educational qualification level of a specialist) can at their choice, either submit the result of the single entrance examination and / or the single professional entrance examination, or pass the relevant entrance examination(s) at CPNU.
- 16. When entering for a Master's degree in the following specialties: 05 "Social and Behavioral Sciences", 07 "Management and Administration", 08 "Law", 28 "Public Management and Administration" applicants could be transferred to vacant places under the state or regional order in the order provided by these Regulations if they are enrolled in training from other sources of open source funding or a fixed offer and have not received a recommendation for places of state or regional order, the persons specified in paragraphs 3, 11 and the fourth paragraph of paragraph 12 of this section.

IX. Ranking lists of entrants and recommendations for enrollment

- 1. The ranking list of entrants is formed by categories in the following sequence:
- entrants, who have the right to enroll according to the results of the interview (based on complete general secondary education and based on educational qualification level of junior specialist, educational-professional degree of professional junior bachelor, educational degree of junior bachelor;
- Entrants, who has the right to be enrolled on quotas can be enrolled only based on the complete general secondary education;
- Entrants, who have the right to be enrolled on general terms.
- 2. Entrants, who are eligible for admission based on the results of the interview, are sorted alphabetically.

Within the other categories specified in paragraph 1 of this section, the ranking list of entrants is organized:

- according to the competition grade from higher to lower;
- according to the priority of the application from the first to the last;
- on the grade of the single professional entrance test;
- according to the average grade of the supplement to the document on the obtained educational (educational-qualification) level from higher to lower.

If the rules set out in the third to fifth paragraphs of this article do not allow to determine the sequence of entrants in the ranking list, the selection committee makes a decision based on the analysis of documents submitted by entrants and enters it in USEDE.

- 3. In the ranking list of entrance such information is noted:
- degree of higher education, specialty, name of the competitive offer, form of education;
- full name of the entrant;
- the average grade of entrant (except those who are enrolled based on the interview);
- priority of the application specified by the entrant (only for competitive offers that use priority);
- an indication of the grounds for enrollment based on the results of the interview, quota-1, quota-2 or quota-3, quota for foreigners (only based on complete general secondary education);
- the average grade of the supplement to the document on the obtained educational degree (educational qualification level) (only if it is taken into account in the competitive grade).

The names of the entrants whose place of residence is the temporarily occupied territory of certain districts of Donetsk and Luhansk oblasts, the territory of settlements on the line of contact, the temporarily occupied territory of the Autonomous Republic of Crimea and the city of Sevastopol (who are not registered as internally displaced persons) or moved from it after January 1, 2022, are subject to encryption in all information systems.

- 4. The ranking lists are formed by the Admissions Committee with USEDE and are published in full on the university's website. The current ranking lists of entrants are published on the official website of the university based on data entered into the EDEBO. Instead of publishing the current ranking lists of entrants on the official website, CPNU may provide links on its official website to the relevant page of the institution in the relevant information system, which informs the public based on USEDE data.
- 5. Lists of entrants recommended for enrollment at the expense of the state or regional budget (under state or regional order) for each competitive offer are received by the selection committee according to the Unified database, checked for authenticity of information including the requirements of the Materials for the development of the

technical task to the algorithm of address placement of state and regional orders in 2022 (hereinafter - Materials for the development of the technical task), listed in Annex 6 to the Terms of Admission, approved by the Admissions Committee and are made public by placing on the information stands of the selection committees and on the website of Chernihiv Polytechnic National University in accordance with the deadlines specified in Section V of these Rules.

The list of entrants recommended for enrollment shall contain the same data as in the ranking list of entrants in accordance with paragraph 3 of this section.

- 6. Address placement of budget places for admission of applicants for higher education with a bachelor's degree, bachelor's (master's degree in medicine, pharmacy or veterinary) based on the complete general secondary education (full-time and part-time forms of education) and applicants for higher education with a master's degree in 05 "Social and Behavioral Sciences", 07 "Management and Administration", 08 "Law", 28 "Public Management and Administration" (full-time and part-time forms of education) on competitive offers based on a bachelor's degree is formed in USEDE bades on competitive points, priorities and ordering of the rating list of entrants taking into account the total, maximum ammounts, the qualification minimum of the state order. The entrant may be recommended for enrollment in the highest priority among those specified by him when submitting applications, according to which the entrant is among those who can be recommended for enrollment in places funded under state (regional) order, according to his competitive grade. The technical task for realization of address placement of budgetary places is formed according to Materials for development of the technical task.
- 7. The official announcement of the recommendations for enrollment is the publication on the official website of the university, based on USEDE data, relevant information certified by a qualified electronic signature of the chairman of the admissions committee or executive secretary of the admissions committee, as well as in the electronic office of the entrant.

Registered entrants may be notified by electronic and mobile means.

X. Realization of the right of entrants to choose a place of study

1. Individuals, who have submitted applications in paper or electronic form and participate in the competitive admission for state and regional orders, after the selection committee decides to recommend for enrollment in accordance with the deadline specified in Section V of these Rules or in accordance with it, are obliged to fulfill the requirements for enrollment in the state and regional order: submit in person the originals of the document on educational (educational qualification) level and its supplement, certificates of external independent assessment and / or other documents provided by the Terms of Admission and these Rules to the University Admissions Committee, as well as to conclude an agreement on training between Chernihiv Polytechnic National University and the entrant (with the participation of parents or legal representatives - for juvenile entrants).

Submission of originals of the necessary documents for enrollment may be made in addition to personal submission by sending scanned copies, with the relevant files of the qualified electronic signature of the applicant, to the e-mail address of the Admissions Committee, specified in the Register of subjects of educational activity of USEDE in the terms specified in section V of these Rules or according to it. If within ten calendar days after the start of training the entrant does not provide the original documents, the enrollment order is revoked in terms of enrollment of such a person.

The contract on education (regardless of funding sources) between Chernihiv Polytechnic National University and the entrant (with the participation of parents or legal representatives - for juvenile entrants) is the basis for issuing an enrollment order. If the entrant has fulfilled the requirements for enrollment without personal submission of documents, the enrollment order may be issued without concluding a contract. If the contract on education is not concluded within ten calendar days after the start of training, this order is revoked in terms of enrollment of such a person.

The submitted originals of documents are stored in Chernihiv Polytechnic National University during the entire study period. An entrant who, after receiving the document on education based on which the admission is made, has changed his last name, first name, patronymic (if any), additionally an entrant personally presents to the admission commission of Chernihiv Polytechnic National University a certificate of state registration of civil status the relevant change and the document issued on its basis, identifying the person whose information is entered into the USEDE. Individuals, who have submitted applications in electronic form, in addition, are required to sign their own application, printed by the selection committee.

In case of enrollment at the expense of individuals (legal entities), an agreement is additionally concluded between Chernihiv Polytechnic National University and an individual (legal entity) who orders a paid educational service for himself or for another person, assuming financial obligations payment.

2. Individuals, who received a recommendation for state or regional order and within the deadlines specified in Section V of these Rules or in accordance with it, did not complied with the requirements for enrollment in state or regional order (except for cases specified in Section XIII of these Rules), lose the right in the current year to enroll (transfer) to study under state and regional order.

Individuals, who have received a recommendation for places of state or regional order and within the time limits specified in Section V of these Rules or in accordance with it, have complied with the requirements for admission to places of state or regional order, are subject to enrollment.

- 3. The procedure for exercising the right of entrants to choose a place of study at the expense of individuals and / or legal entities is determined by these Rules.
- 4. In the case of simultaneous study in several specialties (areas of training, specializations, educational programs) and forms of education, the originals of the document on educational (educational qualification) level, the supplement to it of the state standard, as well as originals of external independent assessment certificates are stored in higher education at the place of study under state order or at the expense of targeted preferential state loans for the entire period of study.

In the case of simultaneous study in several specialties (areas of study, specializations, educational programs) and forms of education at the expense of individuals and / or legal entities, the originals of the above documents are stored in one of the higher education institutions of the student's choice. Certificate of storage of original documents and certified copies of relevant documents are issued at the request of the student by the institution of higher education in which they are stored.

XI. Adjustment of the list of recommended for enrollment

- 1. The Admissions Committee cancels previously submitted recommendations to entrants who have not met the requirements for enrollment in the state or regional order, provided for in article 1 of section X of these Rules.
- 2. Lists recommended for enrollment are updated after fulfillment / non-fulfillment requirements (for enrollment in accordance with Section X of these Rules, taking into account their priority in the ranking list of entrants) by applicants for a bachelor's degree based on the educational-professional level of Junior Specialist, educational-professional level of Professional Junior Bachelor, educational level of Junior Bachelor for obtaining Master's degree based on Bachelor's degree (educational qualification level of Specialist) (except for specialties: 05 "Social and Behavioral Sciences", 07 "Management and Administration", 08 "Law", 28 "Public Management and Administration"), for the acquiring of degree of Doctor of Philosophy.

When updating the lists of recommended for enrollment in the bachelor's degree based on the educational-professional level of Junior Specialist, educational-professional level of Professional Junior Bachelor, educational level of Junior Bachelor, regardless of the competitive grade, recommendations for enrollment are given to entrants mentioned in article 3, 11-13 of section VIII of these Rules, if they are admitted to the competitive selection.

3. Applicants recommended for study at the expense of individuals and / or legal entities are required to meet the requirements for enrollment in accordance with article 1 of section X of these Rules.

In case of enrollment at the expense of individuals (legal entities) within ten calendar days from the date of the beginning of the study, an additional agreement is concluded between Chernihiv Polytechnic National University and an individual (legal entity) who orders a paid educational service for himself or another person, taking financial obligations to pay it. In case of refusal to enter into an agreement within the period specified in this paragraph, this order is revoked in terms of enrollment of such person. Tuition is paid in accordance with the agreement between Chernihiv Polytechnic National University and an individual (legal entity) who orders a paid educational service for himself or for another person, assuming financial obligations to pay for it.

3. The procedure for adjusting the list of recommended for enrollment at the expense of individuals and / or legal entities is determined by these Rules.

XII. Transfer to vacant places under the state (regional) order of individuals enrolled in training at the expense of individuals, legal entities based on complete general secondary education

- 1. Chernihiv Polytechnic National University independently provides recommendations for targeted placement of budget places to entrants based on complete general secondary education within places (except non-budget competitive offers) for which recommendations were provided for enrollment in the relevant competitive offer in accordance with article 6 of section IX of these these Rules, further repealed in accordance with article 1 of section XI of these Rules.
- 2. The right to transfer to vacant places under the state (regional) order is used by individuals who have not received recommendations for enrollment in the places under the state (regional) order.
- 3. The transfer to vacant positions under the state (regional) order of individuals enrolled in training at the expense of individuals and / or legal entities based on complete general secondary education is carried out in the following sequence:
- persons specified in article 11 of section VIII of these Rules, regardless of the competitive grade;
- persons specified in article 8 of section VIII of these Rules;
- persons specified in article 12 of section VIII of these Rules, if they received a competitive grade less than the passing grade (minimum score, which allowed to obtain a recommendation for enrollment in place under the state order for this competitive offer in the general competition in accordance with article 6 of section IX of these Rules) not more than 15 points (25 points for specialties defined in the List of specialties to which special support is provided) (annex 2);
- persons specified in article 13 of Section VIII of these Rules, if the competitive grade received by them is less than the passing grade by no more than 15 points (only for specialties specified in the List of specialties that receive special support);
- persons who have not received recommendations for enrollment under the state (regional) order in the manner prescribed by article 6 of section IX of these Rules (only for specialties defined in the List of specialties to which special support is provided), if their competitive grade is not less than special passing competitive grade established by the selection committee the day after the announcement of the address placement of budget places.

If persons who have not completed their studies at the expense of the state or regional budget (under state or regional order) at a certain level of higher education and received a recommendation for enrollment under the state (regional) order in accordance with article 6 of section IX of these Rules, but not started training due to the impossibility of reimbursement to the state or local budget of funds spent on training services, in accordance with the Procedure for reimbursement of state or local budget funds spent on the payment of training services approved by the Cabinet of Ministers of Ukraine from 26 August 2015 No 658, for the vacant places under the state order may be transferred the next ranked persons who have

not received recommendation for enrollment in the places under the state order as of the date of transfer (in agreement with the state or regional customer).

Transfer to vacanct places under the state (regional) order of the persons specified in paragraphs two - five of this article is carried out in the absence of non-transferred persons of the previous category or in case of their written refusal to transfer and in sequence from the highest to the lowest place in the rating list within each of these categories.

4. In case of lack of sufficient places for transfer to vacanct places under the state (regional) order CPNU uses for this purpose vacanct places under the state (regional) order in other specialties of this branch (only for the persons specified in paragraphs two - five 3 of this section), and in their absence the vacat places of other fields of knowledge could be used (only for persons specified in paragraphs two - four of article 3 of this section) of different forms of higher education acquisition (after transfer to vacanct places under the state order of persons specified in article 3 of this section on the relevant specialty and form of education). The relevant state (regional) customer is notified about it immediately.

Unused places under the state (regional) order after that are considered as not placed in Chernihiv Polytechnic National University. The university informs the state (regional) customer about their number in terms of specialties (specializations) and forms of education. If there are not enough places to transfer to vacanct places under the state (regional) order of persons specified in the third paragraph of article 3 of this section, CPNU sends a request to the state (regional) customer to allocate additional places under the state order at the expense of returned. The decision on the use of these places is made by the competitive commission of the state (regional) customer.

XIII. Enrollment order, additional competition, enrollment at the expense of the target preferential state loan

- 1. Orders on enrollment are issued by the rector of Chernihiv Polytechnic National University based on the decision of the admissions committee. Enrollment orders with annexes to them are formed in USEDE and published on the information stand of the Admissions Committee and the website of Chernihiv Polytechnic National University in the form of a list of enrolled within the time limits set in Section V of these Rules or in accordance with it.
- 2. The decision of the admissions committee on the enrollment of the entrant may be revoked by the admissions committee in case of violations of the entrant, provided for in article 5 of section XV of these Rules.

Enrolled persons may be removed from the order of enrollment in the Chernihiv Polytechnic National University (the order of enrollment is revoked in the part concerning this person) at their own request. Persons expelled at their own request of the Chernihiv Polytechnic National University, the documents submitted returned no later than the next day after the submission of the application for expultion.

3. If a person does not start studying without good reason within 10 calendar days from the date of their start, the enrollment order is revoked in the part concerning this person.

4. An additional competitive selection (in agreement with the state or regional customer) from among the persons who participated in the competition for this competitive offer may be held for the vacant place(s) in accordance with the procedure provided for in article 2 and 3 of this section. Entrants who submitted an application for this competitive offer and were admitted to the competition take part in the additional competitive selection according to the competitive grade. In the absence of such applicants for vacanct places, it is allowed to enroll persons from the competitive offers of this institution of higher education, in case of coincidence of entrance examinations by transferring the application (with the consent of the person) to another competitive offer.

Additional competitive selection is held until September 15, and orders on enrollment of such persons are formed and submitted to USEDE by 18:00 on September 19.

5. The decision on enrollment of the entrant with payment of his education at the expense of the target preferential state credit is made on the application of the entrant submitted to the selection committee, based on the results of participation in the competition in accordance with these Rules.

The persons specified in article 13 of Section VIII of these Rules have the preemptive right to enroll (transfer) to the places financed at the expense of the target preferential state credit. Other categories of entrants have the right to enroll (transfer) to places financed by a targeted preferential state loan, is granted in the absence of persons of the above category or their written refusal of such places.

Applications of entrants enrolled in the state or regional order for a bachelor's degree, a bachelor's degree based on complete general secondary education and for a master's degree in the fields of knowledge 05 "Social and Behavioral Sciences", 07 "Management and Administration", 08 "Law", 28 "Public Management and administration" are excluded from competitions for other places at the expense of individuals or legal entities, except the cases where the applicant submits a separate application in compliance with the requirements for admission to state or regional orders provided for in article 1 of Section X of these Rules.

XIV. Peculiarities of admission of foreigners and stateless persons to higher education institutions

1. Admission of foreigners and stateless persons to Chernihiv Polytechnic National University is carried out in accordance with the Laws of Ukraine "On Higher Education", "On Legal Status of Foreigners and Stateless Persons", "On Ukrainians Abroad", "On Refugees and Persons in Need of additional or temporary protection ", Decree of the President of Ukraine of June 3, 1994 No 271 "On measures to develop economic cooperation of regions of Ukraine with adjacent regions of the Republic of Belarus and administrative-territorial units of the Republic of Moldova ", Resolution of the Cabinet of Ministers of Ukraine of September 12, 2018 No 729 "Issues of higher education by certain categories of persons", Order of the Ministry of Education and Science of Ukraine of November 1, 2013 No 1541 "Some issues of recruitment and training (internship) of foreigners and stateless persons", registered in the Ministry of Justice of Ukraine on November 25, 2013 No 2004/24536, by order of the Ministry of

Education and Science of Ukraine of December 2, 2019 No 1498 "On approval of the Procedure for establishing quotas for higher education by foreigners and stateless persons within the scope of the state order in accordance with international agreements of Ukraine", registered with the Ministry of Justice of Ukraine on February 10, 2020 No 153/34436.

2. Foreigners and stateless persons (hereinafter - foreigners) may obtain higher education at the expense of individuals and / or legal entities, unless other options are not provided by international agreements of Ukraine, the binding nature of which was approved by the Verkhovna Rada of Ukraine, legislation or agreements between higher education institutions about international academic mobility.

Admission of foreigners to Chernihiv Polytechnic National University for study at the expense of the state budget is carried out within the quotas for foreigners (except for foreigners and stateless persons, including foreign Ukrainians permanently residing in Ukraine, persons recognized as refugees and persons in need additional protection).

Admission of foreigners is carried out for accredited educational programs.

- 3. Enrollment of entrants from among foreigners to study at the expense of individuals and / or legal entities may be carried out:
- twice a year, before and at the beginning of academic semesters (but not later than November 1 and March 1, accordingly), to obtain the degrees of junior bachelor, bachelor, master;
- during the year for postgraduate and doctoral studies.

Chernihiv Polytechnic National University calculates the points / grades of the entrant based on the document on of the previous level of education and sets the minimum required for admission the number of points / grades in general subjects for which the entrance test is conducted.

Enrollment of foreigners in the relevant level of higher education is based on the results of entrance exams in certain subjects and languages and based on academic rights to continue education, provided by the document on the level of education in the country of origin, and taking into account continuing education at the next level of higher education in accordance with the legislation of the country that issued the document on the degree (level) of education.

- 4. All categories of foreigners entering the study are enrolled in higher education institutions of Ukraine based on enrollment orders. Confirmation of the fact of studying can be a certificate generated in USEDE.
- 5. Requirements of Chernihiv Polytechnic National University regarding the suitability of entrants from among foreigners who came to Ukraine to study, the conditions of admission to the relevant levels of higher education, as well as deadlines for applications and documents, entrance examinations, creative competitions and enrollment are given in Annex 4 Rules.
- 6. Foreigners who receive state scholarships under international agreements, national programs, and other international obligations of Ukraine are admitted to study

within the established quotas for foreigners based on directions from the Ministry of Education and Science of Ukraine.

- 7. Foreigners arriving in Ukraine to participate in academic mobility programs or to obtain higher education in educational programs agreed between Ukrainian and foreign higher education institutions are admitted to study taking into account the relevant contractual obligations of the relevant higher education institutions.
- 8. Foreigners and stateless persons, including Ukrainians living abroad, who permanently reside in Ukraine, persons recognized as refugees and persons in need of additional protection, have the right to higher education at the same level with citizens of Ukraine, in particular under the state or local budget, with the exceptions established by the Constitution of Ukraine, laws of Ukraine or international agreements, the binding nature of which has been approved by the Verkhovna Rada of Ukraine.

Foreign Ukrainians whose status is certified by a foreign Ukrainian certificate (except for persons permanently residing in Ukraine) may enroll in state-ordered education within the established quotas for foreigners by interview in subjects covered by the Rules of Admission.

XV. List of opportunities for training people with special educational needs

- 1. In order to implement the state policy to ensure the right of persons with special educational needs to education and guided by the provisions of the Constitution of Ukraine (Article 21, Article 24, Article 53), the Law of Ukraine "On Higher Education" (Article 3, Article 4, Part 1, Article 9, Article 2, Article 32), as well as acts of international law the Salamanca Declaration, the Universal Declaration of Human Rights (Article 26), the World Declaration on Education for All, the National University "Chernihiv Polytechnic" carries out the following measures to inform about the rights to education of persons with special educational needs:
- Systematic and continuous educational work of research and teaching staff among students of secondary schools of the city and region, their parents, including secondary schools with inclusive education on learning opportunities at the University based on cooperation agreements.
- Distribution of brochures, printed materials on this issue among public organizations, specialists of various institutions and organizations.
- The Center for Inclusive Education of Chernihiv Polytechnic National University was established (Regulations on the Center for Inclusive Education of Chernihiv Polytechnic National University of April 25, 2015), which disseminates information on the provision of educational services by the University and the Center for People with Special Educational Needs.
- Dissemination of information on the website of the University about the creation of affordable education for people with special educational needs the possibility of part-time (distance) form of education.
- Dissemination of information on the University website about the rules of admission to the University, including for persons with special educational needs.

- Dissemination of information on the website of the University of the psychological service of the University, which provides support for people with special educational needs.
- 2. The following opportunities have been created for the training of persons with special educational needs at Chernihiv Polytechnic National University
- Architectural accessibility is provided barrier-free entrance to the premises (presence of a regulatory ramp); smooth movement in the surrounding area.
- Ensuring the safety of the environment warning students, visitors about areas that pose a potential danger.
- Providing distance learning for people with special educational needs.
- Formed communication skills of research and teaching staff to work with people with special educational needs.
- Availability of an educational program in certain specialties for the training of persons with special educational needs (applicants for higher education from other countries).
- Ensuring free attendance of higher education students in accordance with the Procedure for granting permission to freely attend higher education classes of Chernihiv Polytechnic National University (No 3 of March 25, 2019).

XVI. Ensuring openness and transparency during the admission procedure to Chernihiv Polytechnic National University

1. The Education Ombudsman and / or the employee of the Education Ombudsman Service, representatives of the mass media (not more than two persons from one mass medium) have the right to be present at the meeting of the Admissions Committee.

For accreditation, a journalist submits an application addressed to the rector and personally presents a certificate. Applications for accreditation are accepted within 30 days after approval of the selection committee. The decision to grant accreditation is made at a meeting of the selection committee.

- 2. Non-governmental organizations may apply to the Ministry of Education and Science of Ukraine to grant them the right to observe the work of the selection committees. Non-governmental organizations granted such a right by the Ministry of Education and Science of Ukraine may send their observers to the meetings of the admission commissions. Admissions committees are obliged to create appropriate conditions for the presence of public observers at their meetings, as well as to provide them with the opportunity to familiarize themselves with the documents provided to the members of the admissions committee before the meeting.
- 3. Chernihiv Polytechnic National University is obliged to create conditions for acquainting entrants with a license to conduct educational activities, certificates of accreditation of the relevant specialty (direction of studying, educational program). Admission rules, information on the licensed volume and the amount of admission under the state order for each competitive offer (specialty, educational program, field

of study) and degree, including the number of places allocated for admission under quotas, published on the website of the higher education institution no later than the working day, the following day of approval or acquring of relevant information.

- 4. The chairman of the selection committee announces the meeting of the commission no later than the day before the day of the meeting, in special cases no later than three hours before the meeting. The announcement together with the draft agenda of the meeting is published on the official website of Chernihiv Polytechnic National University.
- 5. Institutions of higher education, which included entrants who provided certificates of health care institutions to confirm the special conditions for participation in the competitive selection or special conditions for higher education at the expense of state or local budget (under the state or regional order) and targeted preferential state loans, must within one month from the date of enrollment, but not later than November 15, make a request to the relevant health care facilities to confirm their special conditions. Inquiries from higher education institutions and responses from health care facilities are uploaded to USEDE.
- 5. Submission of inaccurate personal data, inaccurate information about previous education, the right to enroll in quotas, the right to special conditions for participation in competitive selection or special conditions for higher education at the expense of state or local budget (under the state or regional order), on participation in student Olympiads, on passing an external independent assessment, a single entrance exam, a single professional entrance test is the basis for revoking the order of enrollment in the part relating to this entrant.
- 6. Informing the public about the licensed volume, the amount of places funded by the state order, the cost of studying in specialties (areas of studying, specializations, educational programs), persons (full names and initials) who applied for admission, their recommendations for enrollment and enrollment in Higher education institutions is carried out by information systems based on USEDE data through the "Introduction" section of the USEDE website at: https://vstup.edbo.gov.ua/, as well as information systems in accordance with the agreements concluded by the owners (managers) of such systems with technical administrator of USEDE).
- 7. The list of those who submitted documents for the wide competition is published in the "Entry" section of the USEDE website at: https://vstup.edbo.gov.ua/ at least twice during the period of acceptance of applications and documents.
