**The following must be included in the abstracts:** UDC, surname, initials, position of the author, place of work (study), title of the abstract, keywords. For higher education students and doctoral candidates, the full name of the scientific supervisor, their place of work, and position must also be specified.

**Authors are encouraged to write a brief summary of 3-5 lines at the end of the abstract. All materials will be posted on the website of the National University 'Chernihiv Polytechnic'.**
