Margins – 20 mm on all sides.

The list of references should be provided at the end of the abstracts with mandatory citations in square brackets in the text, and it should be formatted according to the requirements of DSTU 8302:2015.

The following information must be included in the abstracts: UDC, author's last name, initials, author's position, place of work (study), title of the abstracts, keywords. For students and postgraduates: full name of the academic supervisor, their place of work, and position.
